

## Parental Consent Release and Waiver of Liability and Assumption of Risk Agreement

FOR GOOD AND VALUABLE CONSIDERATION, including permission for the participant, a minor, to participate in the Junior Lifeguard Program & related activities, I, the parent/guardian of the minor for myself & on behalf of the minor:

1. Consent to the minor's participating in the event or activity;
2. Agree that prior to the minor's participation in the event or activity, the minor and I will inspect the facilities, equipment, and areas where the event or activity is being conducted and, if either of us believes any of them are unsafe, I will immediately advise the person supervising the event, activity, facility or area;
3. Acknowledge that the minor and I fully understand that the minor's participation may involve risk of serious injury or death, including economic losses, which may result not only from the minor's own actions, inactions, or negligence, but also from the actions, inactions or negligence of others, the condition of the facilities, equipment, or areas where the event or activity is being conducted, the rules of play, or this type of event or activity;
4. Understand and acknowledge the contagious nature of COVID-19 and voluntarily assume all such risk that my minor and I may be exposed to or infected with COVID-19 through participation in the Junior Lifeguard Program, and that such exposure or infection may result in personal injury, illness, permanent disability and/or death;
5. Release, waive, discharge and relinquish the Junior Lifeguard Program (Permittee/Sponsor), the City of Long Beach, and their officers, employees, and agents from any liability, loss, damage, claim, demand or cause of action against them attributable to the minor's participation in the event or activity, whether same shall arise by their negligence or otherwise;
6. Assume any and all risks of personal injuries to the minor and authorize the City of Long Beach or the Permittee/Sponsor to contact or employ a licensed physician to render any medical treatment that may be deemed necessary for the minor or to take and admit the minor to any hospital. If such medical treatment or hospitalization is required, I agree to pay all medical and hospital bills relating thereto, permanent or partial disability, or death and damages to the minor's or my property, caused by or arising from the minor's participation in the event or activity;
7. Covenant not to sue or present any claim for personal injury, property damage, or wrongful death for or on behalf of the minor against the Permittee/Sponsor, the City of Long Beach and their officers, employees, and agents attributable to the minor's participation in the event or activity;
8. Agreement that photographs, pictures, slides, movies, or videos of the minor may be taken in connection with the minor's participation in the event or activity without compensation from the Permittee/Sponsor or the City of Long Beach and consent to the use of the photographs, pictures, slides, movies, or videos for any legal purpose (ie. program DVD sales);
9. Warrant that the minor is in good health and has no physical condition that would prevent the minor from participation in the event or activity;

10. Acknowledge that the City of Long Beach and Permittee/Sponsor are not joint sponsors, joint ventures, partners, or otherwise jointly engaged in the above-named event or activity;

11. Will comply with all State and City regulations and orders pertaining to COVID-19, including but not limited to wearing face masks and maintaining physical distancing. I understand and agree that my minor cannot participate in the Junior Lifeguard Program if they have a fever (100 degrees or greater), chills, cough, shortness of breath, difficulty breathing, fatigue, body or muscle aches, headache, new loss of taste or smell, sore throat, congestion or runny nose, nausea, vomiting or diarrhea.

**IMPORTANT: THIS DOCUMENT RELIEVES THE JUNIOR LIFEGUARDS, THE CITY AND OTHERS FROM LIABILITY FOR PERSONAL INJURY, WRONGFUL DEATH, AND PROPERTY DAMAGE CAUSED BY NEGLIGENCE.**
